Prof. Karen Q. Cheung, Acting President & Secretary-General of UNESCO Hong Kong Association



Prof. Cheung has been committed to the research and development of UNESCO's (United Nations Educational, Scientific and Cultural Organization) education for sustainable development since 2002 and she is active in planning and promoting education for sustainable development. She is a Senior Fellow of World Institute of Sustainable Development Planners (WISDP) and a Certified Sustainable Development Planner (CSDP).

Prof. Cheung is the Director of Hong Kong Institute of Education for Sustainable Development; Executive Director (Hong Kong) of National Working Committee for UNESCO Project on ESD; Expert Advisor & Chair of the Expert Committee, UNESCO Asia-Pacific Institute of ESD; President of World Institute of Sustainable Development Planner; Director of GHM Greater Bay Area Education Forum.

Felix K P Chung is at present the Member of the sixth Legislative Council of HKSAR (Textiles and Garment Sector). He graduated from BSc in Quantity Surveying in 1986 in the Robert Gordon University Aberdeen, UK and followed with his MBA degree in Stirling University, Stirling, UK in 1987. He joined his family business in a knitwear factory in late 1988.

Felix Chung also has a good linkage with the Textile & Garment trade and education organizations. In year 2001, with the support from many garment manufacturers, a non-profit making association was formed in the name of the Hong Kong Apparel Society Ltd. (HKAS), Felix Chung was the founder of HKAS and nominated to be Chairman until 2012.

As the President and Chief Technology Officer for TAL Apparel, Delman is responsible for driving the company's long-term strategy in operations, technology and value-added services to customers. Prof. Philip Yeung Kwok-wing, Executive Director of Clothing Industry Training Authority (CITA)



Prof. Philip Yeung Kwok-wing is currently the Executive Director of Clothing Industry Training Authority (CITA) in Hong Kong and an Adjunct Professor of The Hong Kong Polytechnic University (PolyU). Prof. Yeung holds a PhD degree from the Queen's University of Belfast and has been awarded Fellowship from the Society of Dyers and Colourists and the Textile Institute in the United Kingdom, the Hong Kong Institution of Textiles and Apparel, and Textile Association in India.

Prof. Yeung embarked on his teacher career at the Institute of Textiles and Clothing (ITC) of the Hong Kong Polytechnic since 1973. He became Professor and Head of Department in 1995 and was appointed by PolyU as the Vice President in 2000 responsible for the academic planning and development of the University. Prof. Yeung owned a number of patents and published over 130 papers in journal publications and presented at international conferences over the years.

Currently, his research interest is in sustainable textile product development, and he is also actively conducting consultancy projects in the application of quality management for the industry.
